FINANCIAL PROGRAMS

• Shared Risk 100% Refund Program

The Shared Risk 100% Refund Program is open to couples who meet the eligibility criteria. In this program, the patient pays one flat fee that includes all the costs associated with up to six fresh IVF cycles (excluding medication) and any resulting frozen embryo transfers (FETs). This program includes cryopreservation and storage of embryos from those six cycles and unlimited FETs. If you are not successful or opt out of the program, 100% of the fee is refunded.*

Multi-Cycle Discount Program

In the Multi-Cycle Discount Program, the patient pays one flat fee that includes all cycle monitoring, up to two fresh IVF cycles, cryopreservation and the first year of embyro storage, and unlimited frozen embryo transfers (FETs), if embryos meeting our standard criteria for cryopreservation are available. By prepaying for multiple IVF treatment cycles, this option provides a 40% discount off the cost of two IVF cycles and subsequent FET cycles.

Shared Help Program

This program offers discounts to patients who have no insurance coverage for procedures and services needed, and limited personal resources to cover the out-of-pocket expenses. Criteria to participate in this program include:

- Annual gross household income of \$95,000 or less (based on last 2 years of U.S. federal tax returns)
- Uninsured or denied insurance coverage for treatment and procedures
- · Resident of the United States
- Services need to be rendered at Shady Grove Fertility
